If you are considering a planned gift, please consult with loved ones, professional advisors, and attorneys. You may designate your gift either to the general operating fund of the church, to the endowment, or to a specific area of ministry that is most meaningful to you.

Planned gifts can be made during your lifetime or occur after your death. Forms of planned gifts include:

- Naming the church as a beneficiary of your retirement account or insurance policy
- Charitable gift annuities or charitable remainder trusts
- Making a gift via a donor advised fund or a charitable IRA disbursement
- Giving appreciated securities, such as stocks, bonds, or mutual funds
- Making a bequest in your estate plan

Grace & Holy Trinity Church wants to honor donors' philanthropic wishes and will document those details in a confidential memo, which is kept on file at the church.

In order to make a bequest, you should contact your attorney. Direct bequests can vary; typically, they are a percentage of your overall estate or a specific dollar amount of an asset. Alternatively, you can make a residual bequest (the balance of an estate after the will or trust has given away specific bequests).

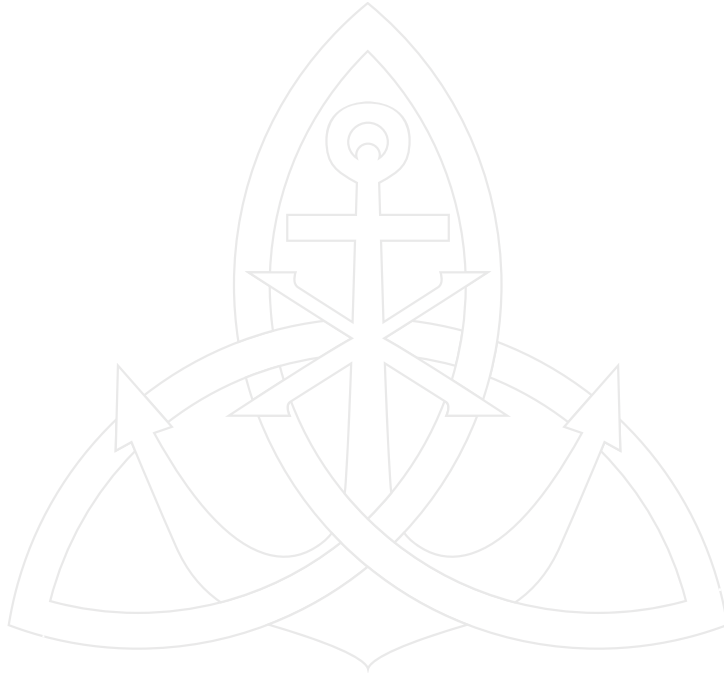
